Healing Generations Therapist

Position Title: Healing Generations Therapist (Youth-focused)

Position Description:

We have a unique and exciting opportunity for mental health professionals who have a passion in working with children and youth! Our Healing Generations program, which includes mental health therapy and Targeted Mental Health Case Management services is growing to include another full-time Healing Generations Therapist to provide culturally appropriate mental health services to Native American students who reside and go to school within the Anoka-Hennepin School District.

Our current team members are working with students who reside and attend school within the Ramsey and Hennepin County boundaries, and we have received a request from our relatives to the North to provide these same services in their school systems!

The Healing Generations Therapist will serve American Indian youth primarily in Anoka-Hennepin school district, with some services provided in the Twin Cities area and at the office located in Saint Paul, MN. A reliable vehicle will be required and willing to commute to various locations to meet with students at different schools will be required for this position.

This person will report to the Clinical Director.

Responsibilities:

- Provision of therapeutic services to children and youth within the school systems
- Provide occasional adult, couples and family therapy
- Provide therapy for those participants who have co-occurring disorders
- Facilitation of therapeutic support groups
- Crisis intervention and consultation
- Perform assessments including diagnostic assessments
- Provide coordination of care for clients
- Facilitate talking circles/support groups for clients and the community at large
- Provide collaborative outreach/networking with family center partners and community agencies
- Maintain client files and confidentiality
- Manage data collection, quarterly and monthly reports
- Promote a chemically healthy lifestyle
- Perform other duties as assigned by the Director

Qualifications

- Master's Degree required. Licensure preferred, or on track toward licensure.
- Licensure in the areas of LP, LICSW, LGSW, LMFT and LPCC preferred
- Knowledge of or desire to learn more about the American Indian culture, community and its resources
- Experience working, planning and implementing programming in a community-based agency preferred
- A valid driver's license and active insurance are required for this position
- Experience in counseling clients who have a co-occurring disorder preferred
- Computer competence
- Attention to detail and good time management skills required
- Effective record keeping skills important
- Excellent verbal and written communications skills required
- No current problems related to drug or alcohol use required

Physical Demands

- Very light lifting (less than 15 pounds) may be required occasionally

Environment
